Schedule L, Part V Supplemental Information	<p>The exempt organization, Pathfinders (PF), is managed by a two member Board of Directors (the Board) consisting of Archer Bishop (Archer) and Kristin MacDermott (Kristin). Archer is Kristin's father. Pillars4Life, Inc (P4L) is a for-profit corporation. Kristin owns 45% of the stock of P4L. PF received a one year grant for \$200,000 (the Grant) from the Painted Turtle (PT), a 501(c)(3) organization, to fund the implementation of psychosocial programming for PT and its participants. PF contracted with P4L to implement P4L's specialized programming in hospitals nationwide, due to the success of the P4L curriculum and training program. PF paid P4L \$190,000 for the services under the Grant. P4L developed a core curriculum and training program that has been meticulously designed to help cancer patients thrive throughout their diagnosis into their recovery. The curriculum provides education in an online group setting. The tools given to the participants in the P4L program include ten 90-minute sessions with a certified instructor and ten participants (plus a partner) as well as a course curriculum. The meetings are planned using timed scripts and other tools. The P4L curriculum also includes a lifetime membership into the Reimagine Community, which is an online support community for cancer patients, survivors, family members and caretakers. The program was proven to be successful in a clinical study conducted at Duke University, which identified patients exceeding life expectancy, patients having increased adherence to biomedical treatment protocols, and patients having fewer tests, calls to medical teams and hospital visits. PF determined that utilizing the P4L curriculum and program was the most effective and efficient way to accomplish its charitable purpose of providing psychosocial support for cancer patients and their partners. The Contract between PF and P4L is carried out at arms length and reviewed and approved by a third party for reasonableness. The oversight of the services provided under the Service Contract is seamless and consistent due to the PF Board/P4L ownership overlap.</p>
